## I. Name and address of the person responsible

## II. Provision of the website and creation of log files

### *1. Description and scope of data processing*

Each time our website is accessed, our system automatically collects data and information from the computer system of the calling computer.

The following data is collected here:

- Version Information about the browser type and version used
- Language and version of the browser software
- The operating system of the user and its user interface
- The Internet service provider of the user
- The IP address of the user
- Date and time of access and time zone difference to the coordinated world time (UTC)
- Transferred amount of data
- Websites from which the system of the user comes to our website
- Websites that are accessed by the user's system through our website
- Access Status / HTTP status code

The data is also stored in the log files of our system.

### *2. Legal basis for data processing*

The legal basis for the temporary storage of data and log files is Art. 6 para. 1 lit. f DSGVO. f DSGVO.

### **3. Purpose of the data processing**

The temporary storage of the IP address by the system is necessary to allow delivery of the website to the computer of the user. To do this, the user's IP address must be kept for the duration of the session.

Storage in log files is done to ensure the functionality of the website. In addition, the data is used to optimize the website and to ensure the security of our information technology systems. An evaluation of the data for marketing purposes does not take place in this context.

For these purposes, our legitimate interest in the processing of data according to Art. 6 para. 1 lit. f DSGVO. f DSGVO.

### **4. Duration of storage**

The data will be anonymized after the *end of each session* .

Data stored in logfiles will be deleted after 7 days. A further storage of the data in a form that allows the identification of the data subjects, does not take place.

## **III. Use of cookies**

### *1. Definition of cookies*

Cookies are small text files that are stored in your browser. These are downloaded from our browser when you first visit our website. When this website is called up again with the same device or browser, the cookie and the information stored therein are either returned to the respective website that generated it (First Party Cookie) or sent to another website to which it belongs (Third Party Cookie ). This recognizes that the web page was accessed with the respective browser and, with this status, changes the display of content. For example, cookies "remember" your preferences, tell you how to use a page and, to some extent, customize the offers displayed.

### *2. Functional cookies*

For the purpose of carrying out the transmission of messages and the provision of the services requested by you, we use the cookies below. The data processing activities that result from the use of cookies are based on our legitimate interests in providing a fully functional website and the services you require (Article 6 (1) (f) DSGVO, Section 96 (3) TKG).

## **VII. Your rights in connection with data processing**

The General Data Protection Regulation (EU Regulation 2016/679) grants you as the person concerned certain rights, to which we refer you below. Please note that these are complementary, so you can only ask for either the correction or completion of your data or their deletion.

### **1. Revocation of consent**

Isosport stores and processes your personal data on the basis of your consent. You are entitled to revoke your consent at any time. However, this does not affect the lawfulness of the processing up to the date of withdrawal.

### **2. Right to information**

You may request information about the origin, categories, duration of storage, recipients, the data processed by Isosport about you, and how they are processed.

### **3. Right to rectification and cancellation**

If Isosport processes personal information that is incorrect or incomplete, you may request that it be corrected or completed. You may also request the deletion of data processed unlawfully.

### **4. Right to restriction of processing**

If it is unclear whether the personal data processed by you is incorrect, incomplete or improperly processed, you may request that your data be processed until such time as the matter has been finally resolved.

#### 5. Right to object

Even if your personal information is accurate, complete and lawfully processed by Isosport, you may object to its processing. But this only in special situations to be justified by you.

#### 6. Right to Data Portability

You may receive Isosport's personal data processed by Isosport yourself in a machine-readable format as determined by Isosport, or you may instruct Isosport to send that information directly to a third party chosen by you, provided Isosport does so technical point of view and the transfer of data neither an unreasonable expense nor legal or other confidentiality or confidentiality considerations on the part of Isosport or third parties.

#### 7. Right of appeal

Finally, you are entitled to lodge a complaint with the Data Protection Authority if you believe that the processing of your personal data in violation of the General Data Protection Regulation (EU Regulation 2016/679).
